The Annual Meeting of Stockholders of Unicycive Therapeutics, Inc. has been called to consider and act upon the following matters:

- Election of four directors;
- Ratification of Mayer Hoffman McCann P.C. as the Company's independent registered public accountants for fiscal year ending December 31, 2023;
- Approval, for purposes of complying with Nasdaq Listing Rule 5635(d), of the issuance by the Company of shares of common stock pursuant to the terms of the private placement financing transaction set forth in the Securities Purchase Agreement dated as of March 3, 2023 between the Company and each of the investors named therein, the Certificate of Designation of Preferences, Rights and Limitation of our Series A Convertible Voting Preferred Stock and the other documents and agreement related thereto, without giving effect to the caps on issuing shares contained therein;
- Approval of an amendment to the Company's amended and restated certificate of incorporation to effect a reverse stock split of the Company's outstanding common stock, at a ratio within the range of 1-for-2 to 1-for-20 with the final ratio to be selected by our board of directors in its discretion at any time, if at all, within one year of the date of the Annual Meeting without further approval or authorization of our stockholders; and
- Approval of the amendment and restatement of the 2021 Omnibus Equity Incentive Plan.
